VOLUNTEER RELEASE and WAIVER of LIABILITY FORM

1., _____ (print volunteer's name) release The South Park Rail Society (the Society), a nonprofit corporation organized under the laws of the State of Colorado and each of its directors, officers, employees and agents, The volunteer desires to provide volunteer services for the Society and engage in activities related to serving as a volunteer.

I understand that the scope of the volunteer's relationship with the Society is limited to a volunteer position and that no compensation is expected in return for services provided by the volunteer and that the volunteer is responsible for his or her own insurance coverage in the event of personal injury or illness as a result of the volunteer's services on the Society.

- Waiver and Release:** I release and forever discharge and hold harmless the Society and its successors and assigns from any and all liability, claims and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to the Society. I understand and acknowledge that this release discharges the Society from any liability or claim that I may have against the Society with respect to bodily injury, personal injury, illness, death or property damage that may result from the services. I provide to the Society or occurring while I am providing volunteer services.
- insurance:** I attest that I have in-force an adequate health insurance or major medical policy to cover medical treatment costs in the event of injury. Further I understand that the Society does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of the Society beyond what may be offered freely by the Society in the event of injury or medical expenses incurred by me.
- Medical Treatment:** I hereby release and forever discharge the Society from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with the Society.
- Assumption of Risk:** I understand that the services I provide to the Society may include activities that may be hazardous to me including but not limited to heavy lifting or involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release the society from all liability.

Other: As a volunteer, I expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and that this release shall be governed by and interpreted in accordance with the laws of the State of Colorado. I agree that in the event that any clause or provision of this release is deemed invalid, the enforceability of the remaining provisions of this release shall not be affected.
